
RECOMMENDATION: Motion authorizing the Executive Director to pay the annual user fees for Washington State Patrol ACCESS system of \$72,000.

BACKGROUND: South Sound 911 provides a regional Law Enforcement Records Management System (RMS) that is used by all 19 police agencies. One module within the RMS is an interface to the state and national criminal information centers, referred to as WACIC/NCIC. In addition to approximately 1,600 criminal justice employees who take advantage of this connection, we have built and maintain several automated processes that rely on a connection to WACIC/NCIC. The Computer Aided Dispatch (CAD) system also connects to WACIC/NCIC through one of its modules.

ALTERNATIVES: The alternative would be to discontinue use of data from WACIC/NCIC, which would eliminate the ability to run “Triple I” criminal history searches and would prevent us from entering Warrants or Stolen Property into the WACIC/NCIC databases.

FINANCIAL IMPACT: \$72,000 (\$6,000 per month, paid in quarterly installments of \$18,000) in 2022. Budgeted funds are available.
