- VII. **Staff Briefing**
 - A. **Executive Director Report**
 - An Interlocal Executive Group comprised of the chief executive officers of the Member jurisdictions has begun meeting monthly to discuss South Sound 911 budget issues.
 - The FireComm employees transitioned to South Sound 911 employment in early January.
 - The CCN board met in mid-December and approved the revised radio system budget and the 10-point plan. If motion today is approved, staff will begin work on the MOU with COT and CCN for radio fees and ISSI implementation.
 - Outside consultant to be engaged to work on strategic plan for operation/management of the radio systems.
 - The Tacoma Fire cutover to the new CAD is anticipated in April.
 - The response and number of officers involved in the November 30th Tacoma Police line of duty death tested the CAD system, which resulted in the MPS component slowing down. The system did not technically crash, but problematic issues were identified. Within 24 hours the issues were identified and Hexagon was very responsive and provided fix for issue. Only the specific incident was affected, all other events functioned normally.
 - Pre-development on the Public Safety Communications Center to begin this month. The demolition of the hospital buildings was put out to bid this month. Construction estimated to start by October. A community meeting held on Wednesday. The neighbors don't want facility to look like fortress. Executive Director Neiditz advised

building will be high security but the design should be compatible with the neighborhood.
